Further, the Trust will work for empowerment of practicing communities, and general public with knowledge, techniques, technologies & skill sets and shall also provide Consultancy services for sustainable Development. It will also act as

1. The trustees shall stand and be possessed of the trust funds solely and completely on behalf of the trust being settled, to receive the interest, dividend, hiring charges, miscellaneous expenditure claims/ recoveries from Govt. Depts./ Corporations/ Organizations/ Institutions /Corporate Entities /Foundations/NGO's etc, CSR Funds, fees, levies, grants, donations, rents and other income from any source thereof and there out in the first place to reimburse themselves or pay and discharge all the expenses incurred in or about or incidental to the administration or execution or any of the trust or amount borrowed for the trust, of these presents and the interest payable on the loans, if any, borrowed by the trustees and also on outgoings, taxes, assessments, dues and duties and other such expenses payable in respect thereof and subject thereto apply the surplus funds at their discretion to the corpus, accumulated funds or apply the whole or any part for meeting any of the objects of the trust, adhering the normal rules framed from time to time by the Income Tax Act & Rules.

2. That the trustees shall in the first instance apply the Trust Fund or any part of the Trust Fund as well as the residue of the said income towards the following main objects of the Trust:

2.1 Himachal Pradesh is a hilly State of the Union of India located in the lap of the Himalayas. Known for its biodiversity and beauty, it is ranked seventh on the Human Development Index (HDI) charts. Also, it is known for its wide diversity of vegetation and plants. The total area of the State is 55,673 square km with a total population of 68,64,602 (2011). Out of the total area, 37,948 square km is covered with forests which is 68%. The State is endowed with a high diversity of medical

and aromatic plants. Himachal Pradesh shares its border with the Union Territories of Jammu and Kashmir and Ladakh to the north, the State of Punjab to the west, Haryana to the southwest, and Uttarakhand to the south. It also shares an international border with Tibet, an autonomous region in China.

- 2.2 During the past few years, it has been observed that this holy State best known as "Land of Gods" is being adulterated by the ill-fated abuse of various kinds of drugs which is causing havoc and destruction to the precious future of the State in the shape of school going children and youths.
- 2.3 In Himachal Pradesh, there are over 10,000 Primary Schools, 1300 High Schools & 1675 Secondary Schools (2023). In Primary Schools, the total number of students is about 5.76 lac, in High Schools about 5.80 lac, and in Secondary Schools this number is about 2.10 lac, totalling about 13.66 lac (2023).
- 2.4 Considering the aforementioned facts, the need of the hour is to save and protect the future of the State, young school-going children and youths by educating, monitoring, tracking and subsequently protecting them from the clutches of drug menace. In this fight against drug abuse, technology can play a big role. Drug usage can be monitored and tracked with the help of customized sensors and other AI tools. These sensors can be in the form of Identity Cards controlled via scientific networks, they can be used to (i) help parents monitor their children's location & activities as and when required, (ii) help school & college administration monitor their students and track their performance, and (iii) help track known drug

peddlers in the State as well as keep vigil on known or vulnerable drug trade spots.

- 2.5 Wildfires cause 20% of the global carbon (Co2) emissions and is equivalent to the total carbon (Co2) emissions by all transportation modes viz. road, rail, air, ships, etc. in the entire world. In the year 2022, a study revealed that 80% of wild forest fires were human-induced resulting in the death of more than 3 billion animals and financial damages exceeding 400 billion US dollars worldwide, and the loss of human lives.
- 2.6 Further as per the report of the Himachal Pradesh Forest Department, there have been a total of 1,684 forest fires since April 15, 2024, the onset of summer. These fires have damaged a total of 17,471 hectares (174.71 Square km) of forest land, causing a significant loss of tree cover, flora fauna, wildlife and human lives in isolated areas. The Visible Infrared Imaging Radiometer (VIIRS) has issued alerts of forest fires since January 1, 2024, noting that between June 5 and June 12, 2024, alone, there were 747 VIIRS alerts. From 2001 to 2023, HP lost 957 hectares (9.57 Square km) of tree cover from fires and 4,37,000 hectares (4370 Square km) from all other causes of deforestation. In the same period, forest fires accounted for 18% of the total tree cover loss in the State.

- 2.7 The present optical tools that are being utilised include the imageries from satellites that capturing images & location of fires. However, dissemination of this data into meaningful information takes 24 to 48 hours and may even increase to 72 hours in some cases. Therefore, we need to use customised Sensors that can be installed in precious and vulnerable forests

to catch such fires and report them within 60 minutes using AI tools & technology. This shall help in the early detection of fires before they become wild and uncontrollable, thereby dramatically reducing the costs of firefighting and saving humans and wildlife. These sensors can further be used for i) determining the fire risk level, ii) tree water consumption, iii) measuring tree growth, and iv) preventing illegal logging, etc.

3. The endeavor of this Trust will be to empower the Government/Institutions/Societies/Organizations to address the issues of (i) Prevalence of drug menace in school children and youths of the Pradesh (ii) Fast depleting forest cover by way of forest fires, illegal deforestation and mining continuing rampantly in the Pradesh. To combat these utilization of the power of scientific networks, AI Tools & IoT solutions is envisaged. Under the execution strategy, it is proposed that the endeavours of the Trust shall be implemented on ground through the Start-Up managed by the young engineers and the technocrats of Himachal Pradesh.

4. Coupled with aforementioned objectives and mission, the vision of the Trust is to prepare Government/Institutions/Societies/Organizations for futures with innovative solutions to not only safeguard and protect the invaluable assets but also drive efficiency, productivity and sustainability.

5. Further, the Trust will work for empowerment of practicing communities with knowledge, techniques, technologies & skill sets and shall also provide Consultancy services for sustainable Development. It will also act as repository of knowledge & its dissemination and provide necessary help whenever and wherever required.

7. The other objects/guidelines of the Trust shall be:

7.1 All the acts which may be for the welfare of the People of the World.

7.2 To provide medical aid to the people and all living beings.

7.3 Eradication of poverty by helping the poor people.

7.4 To provide drinking water to people.

7.5 To start, maintain and assist in relief measures, in those parts of the land, which become subjected to natural calamities like famine, epidemics, fire, flood, dearth of water, earthquakes, storms, hurricane, avalanche, tsunami etc. and to people who become subjected to terrorist attacks and accidents.

7.6 To establish, maintain, assist, finance and support hospitals, nursing homes, diagnostic centre, camps, dispensaries and other medical infrastructure/facility, for the EWS, without any discrimination as to sex, nationality, religion, caste, creed, color, language of and other cause and to make contribution for doing research and treating any new, complex or life-taking diseases.

7.7 To alleviate sufferings of human and other living entities and to protect and fight for human and wild life rights (including rights of fetus, women, children, geriatric age group, weaker, victimized and underprivileged sections/ individual(s)) and for that end to represent before various

government and other authorities, through all kinds of medias, demonstrations, rallies, seminars, street performances, open discussions, lectures and other canvassing modes.

7.8 To eradicate poverty and making poor people self-reliant, by educating and training them in various local, traditional and technical fields, providing/arranging financial assistance and soft loans/ facilities to them, in setting micro and small businesses houses/offering employment opportunities and to ensure that Public Distribution System is made applicable to all the parts of India, to poor and socially excluded families, including to remote places.

7.9 To promote, educate and make the general public aware about social, cultural, economic and other aspects of life, including, helping people to exercise their legal and judiciary rights, to have free access to public information and working, through invoking of Right to Information Act, 2005 and other modes and for that to organize awareness camps, seminars, lectures, street performances, open discussions, forums, rallies and deploy other educational and legal aids.

7.10 To open, found, establish, contribute to the maintenance of orphanages, widow-homes, lunatic asylums and houses for poor.

7.11 To pay stipends scholarships and other aids to underprivileged children for pursuing studies and taking employment.

7.12 To protect culture and heritage of India, save monuments/cities of historic manner, especially among

young generations, so that they become more responsible towards society and their families.

- 7.13 To take measures for protection of environment and surroundings from pollution of all kinds, deforestation and encourage for development of greens on a global, continental and local basis.
- 7.14 To work for the upliftment of underprivileged children, including providing meals, education and shelter to them and for prohibition on child labor, in all sector.
- 7.15 To establish, maintain, assist, finance and support old age homes and offer all kinds of facilities to geriatric age group, including food, clothing, medical and ensuring their human rights and fundamental freedom.
- 7.16 To promote all objects, not covered above, which will be of general public utility and social welfare importance.
- 7.17 To accept donations and subscriptions, from India or abroad, for promoting objects of the Trust, including seeking help/grant/facility from any Department of Indian and other Government, NGO's and other entities, under their respective schemes, plans, sanctions, budgets, charters, objects etc.
- 7.18 The trustee shall have full power and absolute authority to add and introduce such other specific social and charitable objects and purposes according to the advancement of time and circumstances which may from time to time exist.

8. That if at any time hereafter the said trustees shall be satisfied as to non – applicability or danger of application of the corpus or income of the trust fund or any part thereof upon the ground that any of the trusts and directions hereinbefore contained in respect of

the same are illegal and void either as being opposed to public policy or any other ground whatsoever, it is intended and directed that in such cases, the trustees shall apply and expand the said income or corpus towards the execution and carrying out of such of the objects and purposes aforesaid as charitable public objects or purposes according to law.

9. That the surplus and unapplied portion of the income of the trust in any one or more years shall form part of the Trust Fund and the trustee shall have all the aforesaid power qua it.

10. That the trustees shall invest the trust funds in any investment permitted by law for the investment of trust funds including acquisition and construction of properties, movable or immovable, agreed to by the trustees and shall have the right to vary, alienate, or exchange any such investment provided that no transfer, exchange or alienation shall be valid unless made by the trustees unanimously or by majority.

11. That the trustees shall be at liberty to mortgage or alienate any of the trust funds for the purpose of the trust, any money realized pursuant to any such step by the trustees shall be the exclusive property of the trust provided herein. In future the founders may add or remove trustees .

12. That the trustees shall from amongst themselves choose a chair person and co-opt any number of nominees trustees from the public by the consent of the 2/3rd majority of the existing trustees for effective administration of the trust.

13. The trustees shall be at liberty to choose the office bearers amongst themselves or the nominees, in accordance with the term of this declaration, and rules of the trust formed and approved by 2/3rd majority, mandates of trustees as a whole embodied in the form of resolution from time to time, which shall be recorded in black and white.

14. The trustees shall be free to employ, dismiss, terminate, and suspend, permanent, casual, managerial and other staff for day-to-day management of the trust and to meet its objectives.

15. That in the event of any of the trustees dying, declaring or becoming incapable or becoming incapable or unable to act, it is provided that the substitute shall be appointed by a 2/3rd majority of the existing trustees or failing that by the chair person holding office at that time within a period of 6 months of the arising of the aforesaid contingency. Pending appointment of such trustee or trustees the existing trustees shall act in the matters herein provided in these presents as if there was no vacancy.

16. That the trustees may accept subscriptions, donations, contributions, movable, cash or in kind whether, devices, bequests, from India and Abroad for any of the purposes aforesaid and said and dispose of such of them which are not capable of being used for the purposes of the trust and utilize the proceeds thereof.

17. The following provisions shall apply to the meeting, proceedings of the trustees and accounts and audit of the trust.

a. The trustees shall hold ordinary meetings at least four times in a year, with the meeting be spread over four distinct quarters.

- b. Annual meeting of the trustees shall be held once in a year which shall be within six months of the close of the financial year which shall be 31st of March.
- c. A clear notice of seven days shall be given to all the trustees for all meetings with the agenda and business to be transacted or discussed mentioned therein.
- d. Urgent matters can be resolved and transacted by circulation provided 3/5th of the trustees give their assent to it.
- e. Three or 2/5th of the trustees which ever is more shall form the quorum of the meeting and the decision of the majority of the trustees present and a voting shall be binding.
- f. The trustees shall keep a minute book of their proceedings which shall be read out and confirmed in that very meeting or the next meeting.
- g. The trustees shall be duty bound through them or any body under them to maintain the statutory books and proper account books so as to depict the true financial picture of the trust at the principal place of business mentioned hereto above. It would be a pre-requisite to get account audited by a firm of Chartered Accountants to be appointed by the trustees for this purpose.
- h. The trustees shall file all such papers which may be necessary to get the trust registered with the govt. authorities and two of the trustees are empowered to do so. The annual financial statement shall be formally adopted and passed by the board of trustees and income tax returns, approvals and papers shall be signed by two trustees and accordingly filed with the authorities.

- i. The trustees shall be empowered to frame bye - laws, for the purpose of managing the trust and carrying out the objectives of the trust in a special meeting summoned for the purpose provided that the trustees shall not be empowered to change the nature of the trust.
- j. Subject to those provisions the trustees may frame rules of the trust and as well from time to time make regulation as to their meetings and the conduct of their business or otherwise as to the management of the Trust.
- k. The trustees may delegate all or any of the powers, authorities and discretion, herein before conferred on them to any committee or committees such a committee may consist either of some of the trustees together with any other person or persons or of any other persons not being trustees whom the trustees may select by majority, provided that the trustees may at any time revoke either or wholly or partly the authority so conferred on any such committee.
- l. The value of property conveyed and settled upon the trustee is Rs.99,000/- (Rupees ninety nine thousand only) on which the stamp duty as under Article-64 of the Indian stamp Act has been paid.

18. In the eventuality of the Trust not being able to carry on the objectives of the trust for whatsoever reason the trust shall be merged, amalgamated, absorbed or taken over by a Trust/Society carrying on similar objectives.
